## HRM®-COVaxON Report Delivery to Your EMR: Fixing the Bugs

OMD collaborated with the Ministry of Health and Ontario Health to integrate HRM with COVaxON so primary care clinicians could receive vaccination reports in their EMRs. We knew the first release of this solution on May 18 wasn't perfect, but it was better than no COVID-19 vaccination data at all getting to primary care. <u>Some issues</u>, such as <u>duplicate reports</u>, were identified and we worked with our partners to fix them. We are also working on a solution to deliver vaccination information for patients vaccinated prior May 18. If you have any questions

# **Important Reminders**

## Are You Moving? HRM Needs to Know Where You Are!

Just like the post office, HRM needs to know where to deliver your reports. Planning an office move? Switching to another Internet provider? Making a change to your Internet plan? Choosing a new EMR provider? These scenarios could potentially mean a change to your IT delivery location. A change in location will disrupt your HRM feed and you will stop receiving reports from hospitals and specialty clinics. HRM only delivers to locations it trusts, so if any of these scenarios apply to you <u>don't forget to notify</u> <u>OntarioMD</u> at <u>support@ontariomd.com</u> and allow for a <u>minimum of 7</u> <u>business days</u> from the time we receive your <u>complete</u> request with a <u>valid</u> IP address to ensure you don't experience any disruption to HRM report delivery.
