From the CMO's Desk: Happy New Year! COVaxON Reports Poll Results, What's Ahead in 2023 and Beyond

Welcome back! I hope you had a chance to rest and recharge over the holidays.

I want to thank everyone who answered last month's poll about whether you still want to receive COVID-19 vaccination reports via Health Report Manager (HRM®). The results are in, and it's a close call: **49% said 'Yes,' while 51% said 'No.'** The results are too close to make a definitive decision either way. For now, you will continue to receive COVaxON reports via HRM.

These results indicate the different needs of clinicians and that some still find these reports valuable. As you know, OMD is leading the HRM Task Force (see below) and we're assessing the reports sent through HRM from hospitals. During this assessment, we will revisit these vaccination reports.

We're starting 2023 with renewed energy, and exciting opportunities in store for you. OntarioMD (OMD) is working on practical digital health solutions and initiatives to support Ontario clinicians and address your unique practice needs, especially those that ease the administrative burden. HRM Task Force Updates



OMD wants to make sure Health Report Manager (HRM®) continues to be a valuable tool for its users. The HRM Experience Improvement Task Force and working groups are working on eliminating HRM pain points. This takes the cooperation of all HRM stakeholders—Ontario Health, hospitals, EMR vendors, HIS vendors and their decision makers—to execute the Task Force’s recommended solutions.

Update on our work:

The Sending Facility Standards Working Group met on January 12 to understand the impact of fax and electronic duplicates on patients and clinicians and the current state perspective from a hospital lens. Options for addressing duplicates (e.g., draft and final duplicates) were discussed, and discussions will continue on this issue and all pain points brought to the Task Force, along with potential options for addressing them.

We also attend partner events in the health care community to engage with you, your staff and other health system stakeholders.

Access Pharmacy Flu Shots, COVID-19 Vaccinations and Other Drug Data with the DHDR



Fight the flu this season! Fast-track your patient outreach efforts with access to [drug information through your EMR](#) from the Digital Health Drug Repository (DHDR). You can now see which of your patients have received a flu shot at the pharmacy. Also, securely view other important medication information, such as dispensed drugs covered under the

Ontario Drug Benefit (ODB) Program, narcotics or controlled substances, and COVID-19 vaccination information.

Easily Submit Forms Through Your EMR with eForms

OMD is making form completion easier for you with [eForms](#). eForms are digital forms that you can complete from the convenience of your EMR. They are better than other digital forms in EMRs, which when submitted, arrive as faxes to the recipient. With eForms, you no longer have to fax paper or digital forms, only to have them sent back due to being outdated versions, or because something was missing. We're only getting started with eForms. There are 16 forms from the Ministry of Transportation available and more forms are coming!

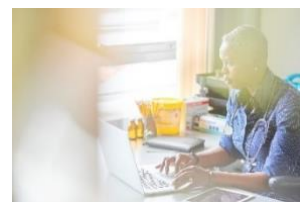
- Replace faxes with more secure forms of digital communication

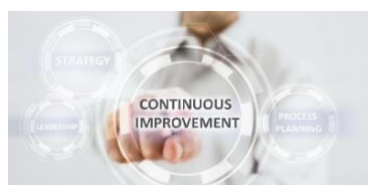
Clinically Appropriate Use of Virtual Care Guidance for Primary Care

Important Reminders

Are You Moving? HRM Needs to Know Where You Are!

Just like the post office, HRM needs to know where to deliver your reports. Moving? Switching Internet providers? Changing your Internet plan? Choosing a new EMR? These scenarios could potentially mean a change to your IT delivery address, disrupting your HRM feed and stopping your reports from hospitals and specialty clinics. HRM only delivers to locations it trusts, so **don't forget to notify OMD** at support@ontariomd.com when making a change. We need a **minimum of 7 business days** from the time we receive your complete request with a valid IP address to ensure you don't experience any disruptions to report delivery.
