HRM Task Force Recommendations: Where do we go from here?

Last month, the HRM Task Force's recommendations were published. Highlighting and understanding the issues with HRM reports and flow were the first giant steps to decreasing the volume of reports and notifications you receive in your inbox. OntarioMD (OMD) has been working hard with Ontario Health to examine the best ways to implement these recommendations overall.

We have almost finalized a few hospitals who want to help formally lead the way to implementation and we are still looking for an EMR vendor to improve the experience on the receiving end. In the meantime, some hospitals have taken action to reduce duplicate reports. The Atlas Alliance hospitals (Ottawa area) went live with their fax suppression initiative so that you don't receive the same reports by fax if you're already receiving them from HRM. Kudos to them! OntarioMD encourages more of these hospital initiatives, and we'll let you know when they go live.

EMR Usability Recommendations



In our last issue, we summarized the HRM Task Force's recommendations for hospitals. In this issue, we cover the **recommendations for EMR vendors** to improve your experience with reports in your EMR:

- To review PDF reports more easily in your workflow: Enable an embedded PDF viewer.
- To auto-categorize reports: Eliminate manual mapping.
- To resolve the inconsistency of HRM Report Service Date vs. Received Date in your inbox: Define and display both Service Date and Received Date.
- **To improve searching for reports:** Create specific searchable fields and a free text search.
- **To help prioritize reports and see relevant clinical information:** Create a one-step workflow for flagging relevant HRM Reports.

Please note: The HRM Task Force's EMR Usability Working Group determined that the Sending Facilities Working Group was better suited to addressing the searchability of PDF reports and their duplication. Therefore, this issue was not addressed in the EMR Usability recommendations.
