# Opioid High-Risk Co-prescribing I4C Indicator MED-OPI-004: Opioid High-Risk Co-prescribing v 2.0

Category: Medication Management/Opioids

## Purpose:

This indicator is used to identify patients potentially at risk due to co-prescribing of opioids with other types of medications: benzodiazepines, z-drugs, pregabalin, or gabapentine.

#### Source:

Based on UK National Health Service Safety Indicators Specification published in 2019.

### **Base Population:**

All patients with an Active demographic status recorded in the EMR who have one or more current opioid prescriptions recorded in the EMR.

### **Indicator Segments:**

<u>Current opioid prescription with current benzodiazepine, z-drug, pregabilin or gabapentine prescription:</u> Count of patients with a current opioid prescription documented AND WITH at least one current prescription documented for any of the following medications: benzodiazepines, z-drugs (nonbenzodiazepine drugs for treating sleep problems), pregabalin, or gabapentine.

<u>Current opioid prescription without current benzodiazepine, z-drug, pregabilin or gabapentine</u> <u>prescription:</u> Count of patients with a current opioid prescription documented AND WITHOUT ANY current prescriptions documented for the following medications: benzodiazepines, z-drugs (nonbenzodiazepine drugs for treating sleep problems), pregabalin, or gabapentine.

A *current opioid prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

'Alfentanil'	'Buprenorphine'	'Butorphanol'	'Codeine'
'Dihydrocodeine'	'Fentanyl'	'Hydrocodone'	'Hydromorphone'
'Meperidine'	'Methadone'	'Morphine'	'Nalbuphine'

A *current benzodiazepine prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

'Alprazolam'	'Bromazepam'	'Clobazam'	'Clorazepate'
'Chlordiazepoxide'	'Clonazepam'	'Diazepam'	'Flurazepam'
'Lorazepam'	'Midazolam'	'Oxazepam'	'Quazepam'
'Temazepam'	'Triazolam'		

A *current z-drug prescription* is any of the following medications (identified by brand or generic name) that is a current (not discontinued) medication:

'zolpidem'	'eszopiclone'	'zopiclone'	'zaleplon'

A *current pregabalin prescription* is a medication identified by the brand or generic name containing 'pregabalin' that is a current (not discontinued) medication.

A *current gabapentin prescription* is a medication identified by the brand or generic name containing 'gabapentin' that is a current (not discontinued) medication.

#### Suggested Indicator Use:

Physician or Practice use of this indicator is to identify/recall patients who may potentially be at risk due to co-prescribing of opioids with other specific types of medications.
