From the CMO's Desk: Advocating for Clinicians



In the May Digital Health eTips, I listed several areas where OMD is working with the OMA and with groups of clinicians to make your life easier.

Let's talk about – the HRM® (Health Report Manager) Task Force.

Many clinicians have been burdened by various types of HRM reports. Additional report delivery concerns have contributed to the administrative burden and these issues have been brought to the attention of OMD. OMD has been advocating on behalf of clinicians to address several regional issues between hospitals and community physicians. 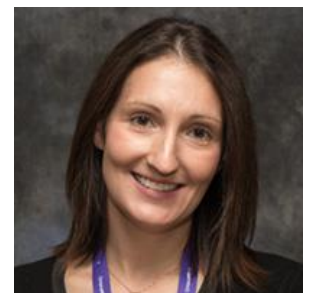
OMD has gathered feedback on HRM pain points and the HRM Task Force met to assess and prioritize them:

- **Volume of reports** – Clinicians feel that they receive too many reports
- **Length of reports** – Reports are too long, making it easy to miss something or hard to find information
- **Duplicate reports** – Clinicians are either receiving the same report by HRM and fax, or the same report multiple times from HRM
- **PDF reports** – They're hard to search and it takes more clicks to view them
- **Lack of report standardization** – Hospitals label reports differently making it hard to categorize them in the EMR and hard to find relevant information
- **Reports go to multiple locations** – Clinicians are receiving the same reports at every location in which they practice for patients not associated with those locations

The HRM Task Force is committed to doing something about these pain points to make improvements. I will continue to update you on the progress of this work. In the meantime, if you have any questions, please contact support@ontariomd.com.

Tip from a Peer Leader: i4C Prevention and Screening Dashboard (Telus, Accuro and YMS)

This dashboard identifies your rostered patients such as children between 18 and 29 months that need an immunization recall or adult patients that need screening for different cancers, or patients who need a recall (including how long they are overdue) using easy to read pie charts. Drug Information and eForms in Your EMR: Who's Next?



Did you know that clinicians can access the medications prescribed to a patient in the community and while they were in hospital? Good news for users of Accuro® EMR, Collaborative Health Record (CHR), EMR Advantage and OSCAR Pro – your EMR vendors are in the process of integrating your EMR to drug information from the provincial [Digital Health Drug Repository](#) (DHDR).

If you use CHR or EMR Advantage, your EMR vendors are integrating your EMR with [eForms](#). eForms are electronic forms accessible from your EMR that make filling out a form and submitting a form much easier and faster. No more outdated or incomplete forms!

Now's the time to get the onboarding process started. Contact support@ontariomd.com or your local OMD representative to request access to these services. YES and YMS EMR users already have access to both drug information and eForms so users can onboard to these tools now.

Hey OHTs: Listen Up!



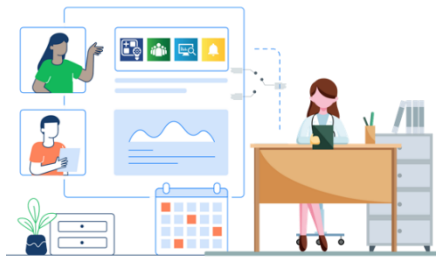

The Ministry of Health released a new version of COVaxON on June 8, 2022. The new COVaxON Clinical Flow Modernization includes improvements to streamline workflow for primary care practices. OMD is offering training sessions on the new workflow. It is highly recommended that you take the training once again to understand the changes. Are You Moving? HRM Needs to Know Where You Are!



Just like the post office, HRM needs to know where to deliver your reports. Moving? Switching Internet providers? Changing your Internet plan? Choosing a new EMR provider? These scenarios could potentially mean a change to your IT delivery address disrupting your HRM feed and stopping your reports from hospitals and specialty clinics. HRM only delivers to locations it trusts, so **don't forget to notify OMD** at support@ontariomd.com when making a change. We need a **minimum of 7 business days** from the time we receive your complete request with a valid IP address to ensure you don't experience any disruptions to report

delivery.
